I understand that this Teacher Cadet curriculum training allows me to teach the content of the Teacher Cadet program using the curriculum materials from the South Carolina Center for Educator Recruitment, Retention, & Advancement (CERRA) and materials that my state, Colorado, has had approved for use with this course.

I understand and agree to support the CERRA requirement not to share the curriculum, in part or whole, with anyone who has not been trained through the CERRA training program.

I understand the Teacher Cadet training provides this agreement to the teacher. Additional teachers who are asked to be a Teacher Cadet instructor from my school will be trained using the Teacher Cadet materials.

I understand that I will teach the Teacher Cadet course on a daily basis or the equivalent time.

I understand that each student enrolled in the program will meet the following criteria:

- Have a GPA/GPR of at least a B average
- Be recommended in writing by three (3) instructors.
- Submit an essay on why he/she wants to be in the class. (The Cadet instructor will keep this essay on file.)
- Be a high school senior or junior.

I understand that I will actively seek to recruit minority/non-traditional students, in keeping with the need to help expand the future pool of minority teachers. Minorities/non-traditional are defined as non-white and/or males.

I understand that I am to teach all the core curriculum components and choose activities that address the standards of the Teacher Cadet program.

I understand that Teacher Cadets will participate and/or observe teaching activities in a variety of settings (kindergarten, elementary school, middle school, high school, career and technical education, special education, and any settings that place a special emphasis on critical content shortage areas).

I understand that I will provide and supervise a field experience for each of my Teacher Cadets; college credit will be recommended based on field experience and portfolio excellence.

I understand that I am expected to attend at least one Teacher Cadet professional development session a year; first year Teacher Cadet teachers are required two 1/2 day curriculum sessions.

I understand that I will provide data on my Teacher Cadets each year to the Colorado Community College System for the purpose of tracking the effectiveness of Teacher Cadet in recruiting talented students into the profession, along with meeting federal mandates (VE 135).
